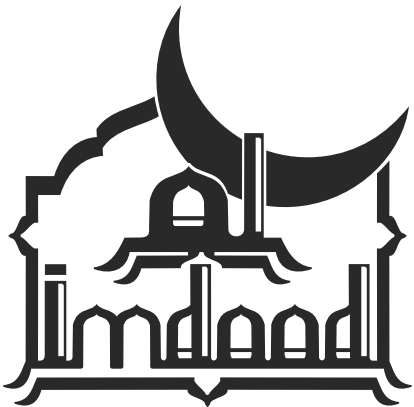

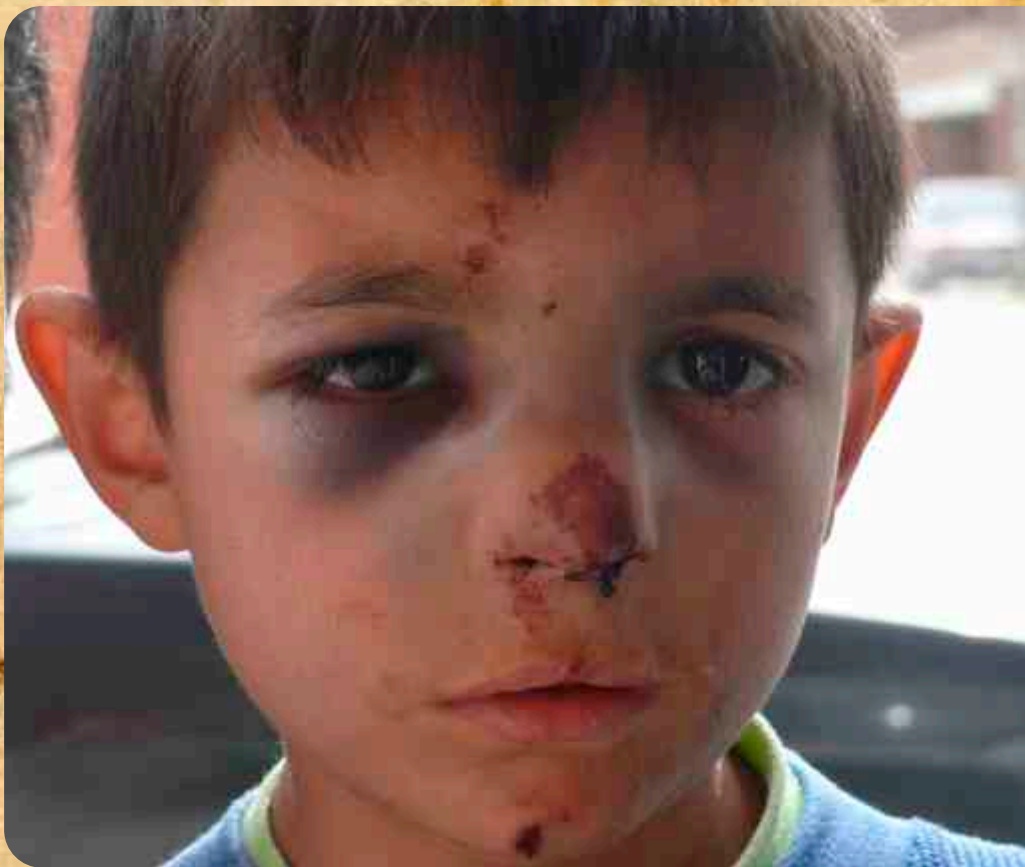

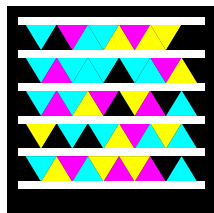

As the world continues to be horrified by the seemingly endless spiral of conflict that has gripped Syria, it is vital to remember that the civil conflict has resulted in a mass refugee exodus into neighbouring countries. Both Jordan, Lebanon and Turkey have seen not only traumatised and homeless refugees pour over their borders, but many maimed and injured Syrians as well.

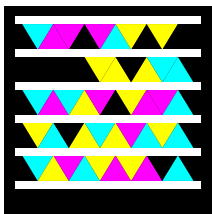
The Al-Imdaad Foundation is at the forefront of the response to those in dire need. In Turkey, where camps were set up by the Turkish government, the Al-Imdaad Foundation provides food, blankets and mattresses and other basic necessities to Syrian refugees. The Al-Imdaad Foundation continues to work in a village on the border, which is a transit point from Syria. In contrast, aid work in Jordan is markedly different. Instead of camps, refugees are housed in the Jordanian border town of Mafraq. Here, the Al-Imdaad Foundation, in conjunction with our Jordanian, British and South African relief teams, register and distribute food & hygiene packs and provide medical assistance to thousands of injured men, widows and children fleeing the savagery in Syria. The essential tasks of rent payment, provision of bedding and food-voucher issuing are undertaken.

The people of Syria are desperately in need of your assistance. Help us to help those in need.

As Ramadaan set in last year (2011), pictures of Somalia in the grip of a devastating drought exploded across our screens. Mobilising speedily, the Al-Imdaad Foundation was able, through various channels, to provide much-needed emergency aid to Somalia. The Al-Imdaad Foundation also recognised the need for an ongoing sustainable solution. To this end, We have managed to establish a field office in the capital, Mogadishu, and have employed local staff and trained them, thereby ensuring that measures are in place that enable them to assess and provide ongoing assistance to those in need.

Through our field office in Somalia, the Al-Imdaad Foundation ensures that assistance is directed prudently to genuine recipients. We have installed numerous water wells in the region in an effort to lessen the impact of the drought on vulnerable communities. To establish a water well at the cost of \$3,500 (USD) or a Mosque at a cost of \$12,500 (USD) please contact our offices.

Arafat Hospital - Somalia

Since the collapse of former government in Somalia, the health sector of the state has totally collapsed. Public hospitals, poly clinics as well as the other health service infrastructures have been completely destroyed. Recognising the need for a fully functional health care facility, the Al-Imdaad Foundation has adopted the Arafat hospital in Mogadishu. This hospital is the largest to have been established since the collapse of the state in 1991 and provides health care to over 126,000 patients a year. Due to the high number of mortality rates caused by a lack of modern medical equipment, the Al-Imdaad Foundation has equipped the Arafat hospital with modern equipment and quality medicines. Volunteer medical teams from South Africa and abroad will be sent to provide free medical care to those suffering the effects of war, drought and poverty.



Gambia



The Gambia is one of Africa's smallest and poorest countries. Ranked 168th of a total of 182 low-income countries on the 2009 Human Development Report of the United Nations Development Programme, Gambia is a country riddled by poverty. With more than sixty percent of the rural population being classified as poor ,the recent global financial crisis resulting in soaring food and fuel prices has led to considerable hardship for many poor rural households in particular.

These crises have impacted the country's economy tremendously, resulting in many more people being forced into extreme poverty. Recognising the need for an immediate intervention, The Al-Imdaad Foundation undertook the task of assisting these poverty stricken communities by establishing a clinic, which included a fully equipped maternity ward in the Kunkujang clinic.

The Al-Imdaad Foundation immediately procured medical supplies and treated patients free of charge at the height of the malaria season thereby enabling us to save even more lives. The Al-Imdaad Foundation had also provided clothing, food and prayer mats together with basic relief items to the impoverished community of Kunkujang.

'Females Only' Hospital

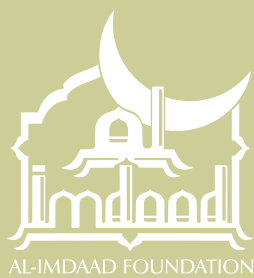


The Al-Imdaad Foundation has been working in Gaza since inception in 2003 and has made tremendous and significant strides in rehabilitating the over-burdened health sector in Gaza and has actively been involved in the first ever “females only” hospital in Gaza. This facility was established to offer medical services exclusively to women by female medical staff and involves no male involvement at any time. The project has been widely accepted in Gaza and has become one of the Al-Imdaad Foundation’s most noteworthy and remarkable projects.

The Al-Imdaad Foundation plays an active role in funding and improving this facility on a continuous basis. The medical complex boasts a wide array of services and houses and includes amongst other departments a pharmacy, laboratory, dental clinic, trauma theatre and radiology department. With your generous support, close to 12,000 babies have been delivered and thousands more have received treatment in this landmark facility.

The Al-Imdaad Foundation is currently in the process of expanding this hospital and also upgrading the medical equipment to cater for the increasing need of specialised treatment. We appeal to you to donate generously towards this project which will indeed bring some ease and comfort to the Palestinian people in their hour of need .

Indonesia



Indonesia lies on the hot bed of the world's 'ring of fire' and is also situated at the convergence of the Pacific, Australia, Eurasian, and Philippines tectonic plates making it a country which has been battered by numerous volcanoes and frequent earthquakes, often with catastrophic effects on its inhabitants.

Since the infamous tsunami of 2004, the Al-Imdaad Foundation has been continuously active in Indonesia via our international branch office in Jakarta. Having established a complete housing village and orphanage in Banda Aceh, the Al-Imdaad Foundation continues its humanitarian efforts to assist the poverty stricken people of Indonesia by undertaking various empowerment projects, feeding schemes and education projects including a 'Darul Uloom' (tertiary islamic education centre), building of Mosques and also madrasahs.

The Al-Imdaad Foundation also carries out an extensive Ramadaan feeding and hamper distribution programme which sees to the needs of the poorest of the poor in even the most rural areas of Indonesia during the blessed month of Ramadaan.

Jordan



The Al-Imdaad Foundation has been working with Palestinian refugees in Jordan since 2004. With your support we are able to serve these refugees on the medical and social front whilst also focusing on their educational development.

We have established a school for the deaf in Mafrag, Jordan and have also funded a fully equipped educational centre for physically and mentally challenged children. Numerous clinics have also been set up amongst refugee camps as well.

The Al-Imdaad Foundation, through our international branch office in Jordan, also runs a successful orphans and widows programme. The medical, schooling and food cost of these recipients are borne by our offices and we strive to continue serving and uplifting these orphans and widows.

The Prophet Muhammed (peace be upon him) said: "I and the person who looks after an orphan will be in Paradise together like this..." - then he raised his forefinger and middle finger together. (Bukhari)

Madagascar



In an attempt to assist the island nation of Madagascar to recover from the devastation caused by cyclones Giovanna and Irina, the Al-Imdaad Foundation together with the Department of International Relations and Cooperation (DIRCO), handed over aid to victims of the cyclones which affected over 300,000 people and left over 100 dead.

Within 24 hours of the request made to the Al-Imdaad Foundation by DIRCO, a consignment of emergency relief supplies was procured and loaded onto an aircraft sponsored by the South African government. These supplies included tents, food, blankets and water purification tablets amongst other relief aid items.

Our emergency relief teams, accompanied by the Deputy Minister Mr Fransman landed at the Antananarivo Military Base where we were received by the Government of Madagascar and the army. The South African Deputy Minister of DIRCO and the Minister of Foreign Affairs of Madagascar personally distributed emergency relief supplies alongside the Al-Imdaad Foundation emergency relief teams to the victims of Brickaville and Moramanga, two of the worst hit areas where houses were flattened, hospitals were damaged and even the most basic medical facilities and medicines were scarce due to the intense damage.

Makeshift tents were being used to provide primary health care services. Even the education sector was disrupted as classrooms and schools had been destroyed. Some of the tents provided by the Al-Imdaad Foundation were being used as classrooms in order to bring back a sense of normalcy in the affected communities of Brickaville.



Turkey



In October 2011, the Van region in Turkey was hit by a deadly earthquake that saw a huge swathe of the region's population left without homes, just as winter was about to set in. In response to a request by the Turkish Government for aid, the Al-Imdaad Foundation provided essential and desperately-needed supplies to the victims of the earthquake.

Feeding centres were set up to ensure hot meals were given three times daily to the victims of the earthquake. Our emergency relief teams from United Kingdom and South Africa also erected snow-resistant tents, thus ensuring some protection to victims against the harsh elements.

Food hampers, baby items and female hygiene packs were also distributed to recipients in even the most remote areas of Van where no help had previously reached.

Pakistan



The Al-Imdaad Foundation, in our rehabilitation efforts for the flood affected victims of Pakistan, has embarked on a project to assist those who have lost their homes and livelihoods.

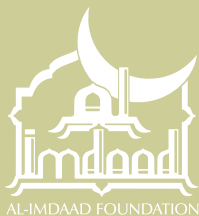
We have secured 26 acres of land in Sanjarpur, Pakistan to build a complete village which includes houses, mosques, tube wells, a school, hospital, market area, cattle yard and a vocational training centre.

We have implemented a community based strategy which encourages beneficiary communities towards basic life skill development, self-reliance, living with dignity and respect and psycho-social rehabilitation. This is aimed at empowering the community in order to shift their attitude from dependency to self-reliance.

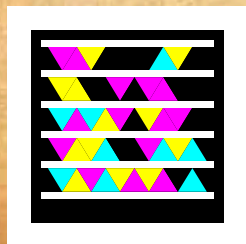
The construction has already begun and we look forward to your contributions which will result in either a widow, orphan, physically challenged or an elderly person having a place they can call home.

The scourge of poverty, illiteracy and inequality is a burden millions of children across South Africa face today. This is as a result of being denied the benefits and opportunities a good education offers. In January 2012, the Al-Imdaad Foundation, in an effort to make education more widely available and affordable had completed its fourth state of the art Early Childhood Development Centre (ECDC) in Mangaung, Bloemfontein, South Africa.

In South Africa similar centres have been established in Estcourt (Kwazulu Natal), Ladysmith (Kwazulu Natal), and Vlakfontein (Gauteng)

This centre was officially opened by the president of South Africa, Mr Jacob Zuma and will serve the education sector within the underprivileged communities of Mangaung, Bloemfontein.

The Al-Imdaad Foundation abides by the philosophy that educating a nation today will result in a brighter tomorrow.

Community Gardens



Community gardens act as a catalyst for neighborhood and community development. Community gardens are also a means of producing nutritious food, creating income opportunities and economic development within a community by drastically improving the quality of lives of previously disadvantaged and unemployed people, giving them the opportunity to provide for themselves as well as their families.

With this in mind, the Al-Imdaad Foundation in partnership with the Umtshezi Municipality and FNB Islamic Finance has initiated a pilot project in Estcourt whereby previously unemployed people are trained and given the opportunity to create an organic garden based entirely on the scientific principles of permaculture which allow for maximum crop yield using only natural agricultural methods without the use of expensive chemical pesticides and herbicides and inorganic fertilizers in the planting process.

This project is the first of its kind in the region and will boast a wide array of fruits, nuts, vegetables and will sustain the livelihoods of many poor people.

Madrasah & Maktab Project

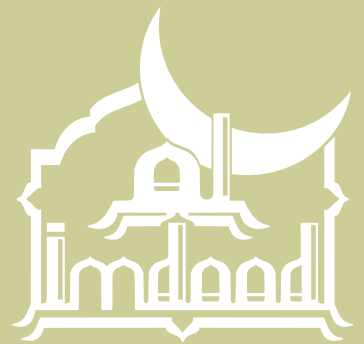

Operation 'Sukuma Sakhe'



Rural areas in developing countries like South Africa are generally characterised by a lack of the basic necessities of life and this inadequate satisfaction of basic needs lies at the core of poverty. Basic needs are those human requirements that are necessary to make human survival and development possible in a given society.

Taking into consideration that a basic satisfaction of needs will afford everyone a better quality of life, the 'Operation Sukuma Sakhe' project of Dr Zweli Mkhize, Premier of Kwazulu Natal is aimed at unlocking development by addressing issues of access to resources that are required for the satisfaction of these basic needs. Through the 'Operation Sukuma Sakhe' project, it is believed that interventions will systematically contribute to the economic growth, community development, job creation, strengthening of institutions and poverty alleviation.

The Al-Imdaad Foundation has partnered with the Premiers' Office in an effort to eradicate the effects of poverty in Kwazulu Natal by implementing projects such as bicycle distribution to learners that walk up to 15 kilometres per day just to attend school. Under this project we have also distributed shoes to learners that go to school barefoot, wheelchairs to the disabled and elderly, new homes to people who have lost everything in just minutes, food and blanket distributions to the poorest of the poor.

This project has indeed made a remarkable difference in the lives of thousands of South Africans.



Operation Winter Warmth



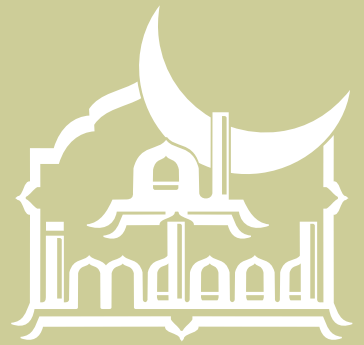
The effects of climate change in recent years results in adverse climatic conditions with the trend continuously changing drastically, making the winters become much more severe and harsh. This impacts the lives of the thousands of impoverished and poor South Africans taking into consideration the many destitute and homeless people together with the increasing number of refugees that can be found in South Africa today.

Answering to the call of our fellow brothers and sisters who have to endure the icy winters, the Al-Imdaad Foundation distributes tens of thousands of blankets, warm hats and gloves across all 9 provinces every winter making our 'Operation Winter Warmth' one of the largest and most comprehensive in the country.

Last year (2011), over 50,000 blankets were distributed across all 9 provinces in South Africa. The trustees, staff and volunteers of the Al-Imdaad Foundation always prioritise poor rural communities as part of our relief efforts especially in the annual winter warmth operations.

This year (2012), the Al-Imdaad Foundation aimed at distributing over 60,000 blankets to poor and needy families. Quality has always been at the forefront of any Al-Imdaad relief project and our operation winter warmth is no exception. Our blankets supercede the minimum standards and specifications laid out by UNHCR, IFRC and UNICEF.

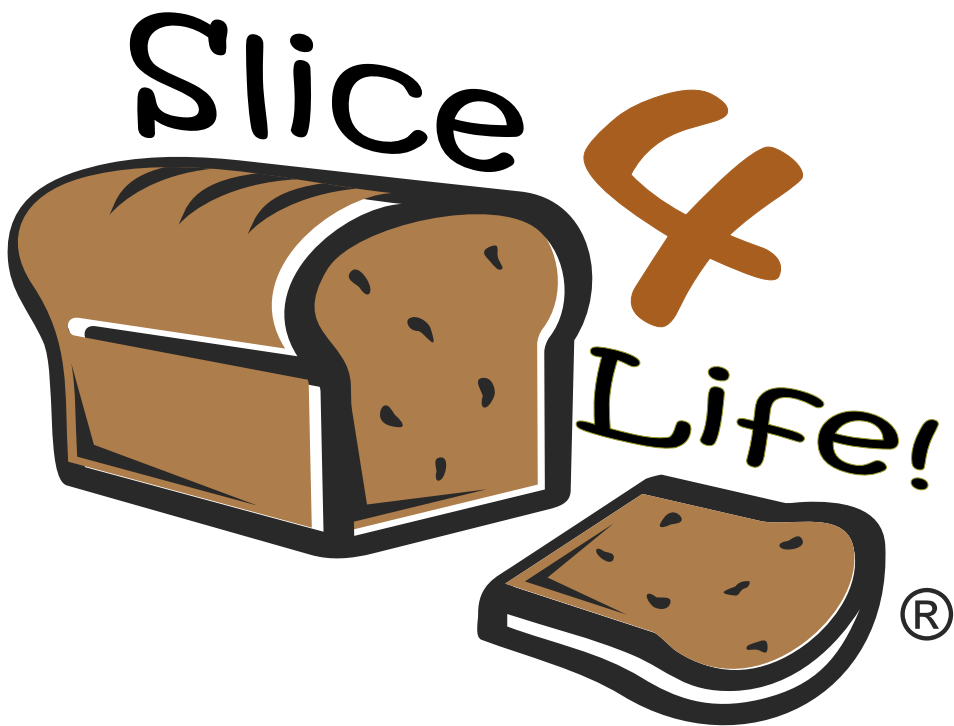

Slice-4-Life™ Feeding Programme

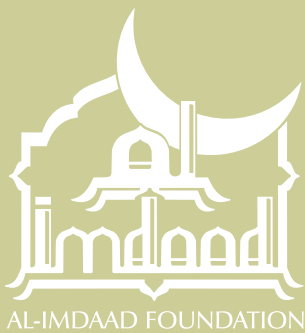


In an effort to eradicate the plight of patients, who are often hungry whilst waiting in long queues to receive medical treatment or to receive their monthly medication, the Al-Imdaad Foundation launched the SLICE-4-LIFE™ feeding campaign in various hospitals and clinics throughout South Africa.

It is indeed heartbreaking to witness young and old patients who leave their homes in the early hours of the morning to join the queues without having had their breakfast. In order to combat this harsh reality, the Al-Imdaad Foundation's SLICE-4-LIFE™ campaign offers a nutritious sandwich to ease the pangs of hunger together with a hot drink to thousands of patients countrywide.

The Al-Imdaad Foundation oversees the daily preparation, packaging and distribution of sandwiches to patients. All sandwiches are hygienically packaged into a specialised wrapping, ensuring that the sandwiches maintain their freshness. This campaign has been adopted by many communities, hospitals and clinics across Gauteng, Kwazulu Natal, Eastern Cape, Western Cape and the Limpopo Province. Over 180,000 sandwiches are currently being prepared and served to patients monthly. Adequate nutrition is essential and crucial; something which many patients cannot afford. Certainly, this project has a positive impact on their health.

Orphans & Widows Care Programme



Financial incapacity has always been a central issue ever since. The struggle to maintain adequate and appropriate levels of health care is still a challenge of many families. One of the negative consequences of poverty is the inevitable increase of needs for physical and occupational rehabilitation. In instances where impoverishes families cannot afford to send ill members to the hospitals and private health care institutions to undergo physical and occupational rehabilitation, the Al-Imdaad Foundation avails the poor and sick access to these services.

We have also partnered with many doctors, surgeons and specialists and other medical practitioners and Air Mercy Services to provide free medical services and free medicines in rural areas.

The Al-Imdaad Foundation hosts 'free medical clinics' in rural villages where patients receive eye treatment and spectacles, dental treatment, ENT specialist treatment, as well as home-based care training done in conjunction with the Islamic Medical Association (IMA) of South Africa.

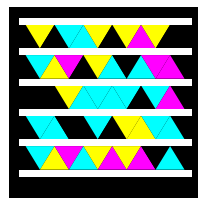

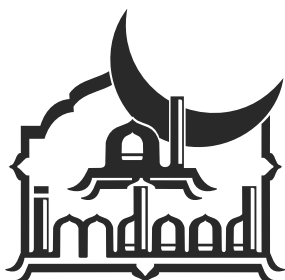
